MARKET COMMENTARY Source: AWI

This weeks national offering was reduced to 29,807 bales due partly to Fremantle having a non-sale week. The market responded to the lower volume and favourable forex by recording an overall increase for the third consecutive series.

The strongest demand was seen in the medium to broader merino fleece types; as a result, the 19.5 to 22 MPGs gained 10-63 cents. Falls in some finer MPGs combined with minimal movements in the skirting, crossbred, and oddment sectors resulted in a modest 7-cent rise in the EMI, taking the benchmark indicator to 1474, a level not seen since March 2020.

Despite the smaller weekly offering, the total amount of wool offered Y.T.D. has increased by 6.4%, while the value has increased by 17% (\$377.6 million).

Next week is the final sale of the 2021/22 season. Once again, Fremantle returns to the selling roster, bolstering the national offering, with 45,003 currently forecast for sale.

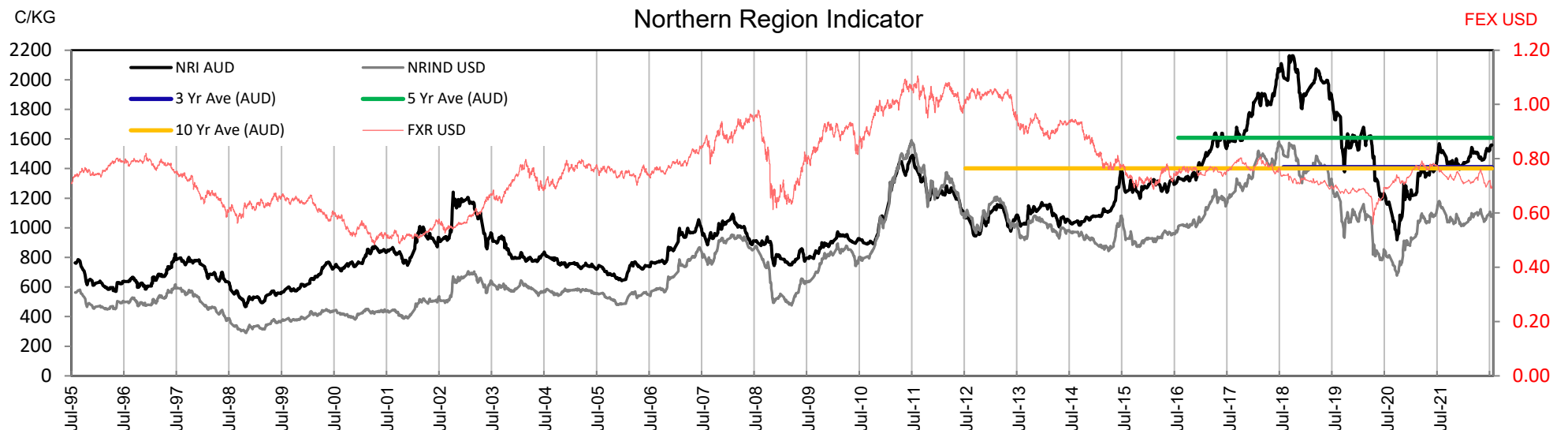

Definitions:

* A Percentile, is a value on a scale of one hundred that indicates the percent of a distribution that is equal to or below it. In general a percentile between 25% and 75% is considered normal, a percentile below 25% is considered below normal and a percentile above 75% is considered above normal.

Three and ten year percentiles shown on the bottom line of table 2 & 3 (above) and in table 1 (on page 1), detail the amount of time during the past 3 & 10 years where the market has traded either at or below its current price.

* Deciles are a method of sorting ranked data into 10 equal groups. The data may be ranked from largest to smallest or vice versa.

The above Decile tables sort price Percentiles into 10 equal groups (in ascending order), with table 2 ranking the previous 3 years prices, while table 3 ranks prices over the previous 10 years.

Example: In Table 2, a Decile Rank of 6 for 19 microns, shows 19 microns have traded at or below 1684 for 60% of the time, over the past three years.

In Table 3, a Decile Rank of 6 for 19 microns, shows 19 microns have traded at or below 1664 for 60% of the time, over the past ten years.
