**MARKET COMMENTARY** Source: AWEX

After a month of continuous rises, the wool market retracted this week. Low vegetable matter (vm) types were again in short supply; these types attracted excellent buyer support and were least affected by the falling market, so too were wools with favourable additional measurements. Lesser style and poorer specified lots did not fare as well, and in many cases were heavily discounted, putting downward pressure on the merino MPGs which generally eased by 5-20 cents.

The skirting, oddment, and crossbred markets recorded minimal price movements; however, 25% of the crossbred offering failed to meet seller expectations and was subsequently passed-in.

As a result of these movements, the EMI gave back 14 cents for the series to close the week at 1,420. However, when viewed in USD terms, the market gained ground, closing 4 cents dearer at 1,008 US.

Next week the national offering decreases. Currently, there is expected to be 37,291 bales offered nationally.



**Definitions:**

\* A Percentile, is a value on a scale of one hundred that indicates the percent of a distribution that is equal to or below it. In general a percentile between 25% and 75% is considered normal, a percentile below 25% is considered below normal and a percentile above 75% is considered above normal.

Three and ten year percentiles shown on the bottom line of table 2 & 3 (above) and in table 1 (on page 1), detail the amount of time during the past 3 & 10 years where the market has traded either at or below its current price.

\* Deciles are a method of sorting ranked data into 10 equal groups. The data may be ranked from largest to smallest or vice versa.

The above Decile tables sort price Percentiles into 10 equal groups (in ascending order), with table 2 ranking the previous 3 years prices, while table 3 ranks prices over the previous 10 years.

**Example:** In Table 2, a Decile Rank of 6 for 19 microns, shows 19 microns have traded at or below 1682 for 60% of the time, over the past three years.

In Table 3, a Decile Rank of 6 for 19 microns, shows 19 microns have traded at or below 1656 for 60% of the time, over the past ten years.
